The forward and aft cabin areas include four (4) place club configurations with leg rests and pull-out tables in select seats.

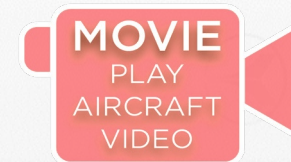

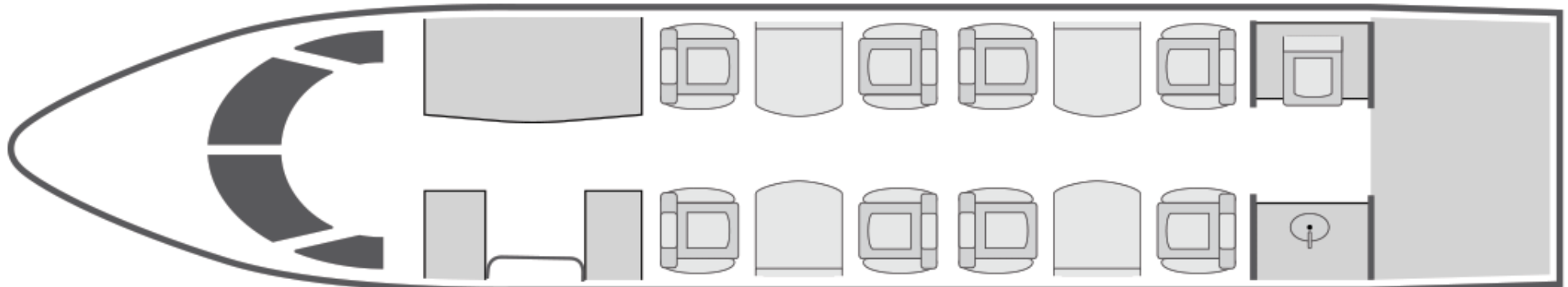
